## SEASON PASS AGREEMENT

The season pass you receive must be presented at the ticket window for a regular lift ticket on each visit. Limit of one ticket per day. Passes are non-transferable and non-refundable. Lost passes can be replaced with a \$10 fee.

### **In support of this application, I agree that:**

1. All information contained in this application is true and correct.
2. My skiing/snowboarding privileges are not transferable and any utilization of my privileges by any person other than me will result in immediate revocation, without refund, of all privileges for the remainder of the season.
3. Christie Mountain Snow Area reserves the right to make reasonable rules for the safety and convenience of its patrons and for the proper utilization of its facilities. I agree to obey these rules.
4. My season pass fee entitles me to lift privileges as stated and when the ski area is open to the general public during the season it is issued.
5. The use of this pass entitles Christie Mountain Snow Area to use any photo of me in publication or promotions now or in the future
6. I understand that no refunds of my fees will be made for any reason.
7. I understand that Christie Mountain Snow Area may close at unexpected times for power peaks, safety of its patrons, due to weather, lightening, high wind, etc. and furthermore, I do not expect any sort of reimbursement if this is to happen.
